





Membership 2004-2005

We are now over half way through the current Elk year. What do your membership numbers reveal? Hopefully a gain at this point, even after considering the delinquents you may have just dropped and those you may have to drop in March. If not, now is the time to begin the necessary steps to change the year end outcome, February or March is too late. The main thing is retaining your current members, once that is accomplished ask a former member to reinstate, call your local stray Elks and recruit new members. All of these are avenues to help grow membership. Also stress Grand Lodge incentives to your membership, institute your own incentive program and encourage participation in the President's New Members Bringing in New Members Program.

Membership growth is the number one priority of the State Association this year. We have full support of our State President, Lee Littiken, and the membership committee is totally dedicated to the goal of a net membership gain. We can have a membership gain this year but not without your commitment. We need the support of every Elks Lodge and every NC Elk to obtain this goal. It is our hope this year, that every member of this association will ask one person to join our organization. We as a group can and must stop the declining trend of membership in our great Order.

Also, State Sponsor, Hon. Gerald L. Coates, PGER is requiring all lodges conduct an initiation during the last regularly scheduled meeting in March. This required initiation is to allow all candidates who are eligible for membership into our Order to become an Elk during the current Elk year. So many times we have carried enough eligible candidates over into the next Elk year, that had we initiated them in March, we would have had a gain in membership instead of a loss. Please have this initiation if you have eligible American citizens. This past

year the association lost 178 members. As of March 31, 2004 we had 224 applications on hand, some of which surely could have been members as of March 31, 2004. Let's not make the same mistake again!!

Please remember to send all the names of new members who have successfully met their objectives in our new "THE PRESIDENT'S NEW MEMBERS BRINGING IN NEW MEMBERS" program. The names should be sent to someone on the membership committee. Please call if you have any questions regarding this program. This program works!! If for any reason you have not instituted this program in your Lodge, please do so now.

Active in the Elks Charitable Trust, Gus has been very active in his church work and serves on his Church Vestry



this fall. The Benevolent and Protective Order of Elks – USA awards 500 Most Valuable Student scholarships at the national level. Annually, Elks fund \$3.4 million in merit and need based scholarships to deserving students. The Lodge congratulates these young men on their stellar academic achievement and wishes them every success as they pursue their goals in higher education.

North Wilkesboro Elks Lodge recently announced local recipients of the Benevolent Partners Of Education – "BPOE" scholarship program. BPOE scholarships are funded at the local level and awarded to Wilkes students in the ninth grade. This conditional scholarship targets "at risk" students selected by school

counselors. BPOE scholarships assure that each student will receive a \$1,000 award upon the successful completion of high school and subsequent acceptance in a two or four year undergraduate program. BPOE scholarships are renewable up to four years. Congratulations to all of our 2004 BPOE scholarship winners.

Elk Scholarships For 2005 2005 Most Valuable Student Contest

Applications should be available to your local high schools starting September 15, 2004.

As in the past you are asked to make photocopies of the material for distribution. The ENF office will ship me a supply of MVS applications, brochures and posters which will be available to you at the state convention in October. Applications will also be available at www.elks.org/enf/scholars starting September 1, 2004, or by sending a self-addressed, stamped envelope to the ENF office.

In order to reduce costs, manuals were not printed this year. Scoring tables and scoring worksheets were mailed for reproduction as needed. The entire manual can be downloaded from www.elks.org/enf/volunteers.cfm.

2005 ENF Legacy Award

The contest is open to any high school senior who is the child or grandchild (or step-child, step-grandchild, or legal ward) of an Elk who has been a member in good standing for at least two years. Applicants will be judged on SAT or ACT scores, high school transcript, and the Biographical Questionnaire. Legacy Award winners will be announced in late April 2005.

Applicants are no longer required to complete an Application Request Form. The applicant must apply through the related member's Elks Lodge, regardless of where the applicant resides. All parent/grandparent membership information is collected and verified by the Lodge Secretary directly on the Biographical Questionnaire. Membership must be verified before submitting the Biographical Questionnaire to the ENF office.

Biographical Questionnaires, complete with transcript, two recommendation letters and essay, must be forwarded to the Foundation postmarked by January 14, 2005.

Emergency Educational Fund Grant Program

The Emergency Educational Fund Grant program provides financial assistance to children of deceased or totally disabled Elks, who wish to obtain or further their college education. Grant amounts range up to \$3,000. The grant is for educational assistance only and not intended to cover the entire cost of a college education.

Potential applicants should meet the following eligibility guidelines before they apply.

1. The Elk parent or stepparent must have been a member in good

standing at the time of his or her death, or the Elk parent or stepparent must have been a member in good standing before he or she became totally disabled and must continue to be an Elk in good standing when application for assistance is made.

2. The applicant must demonstrate financial need to qualify for a grant under this program.

3. In addition, the applicant must be unmarried, under the age of 23 as of Dec. 31 in the year of application, and attending a U.S. college or university as a full-time (12 semester hours) undergraduate student.

All applications – new and renewal – must be submitted to, and processed by, the Lodge where the Elk parent or stepparent is or was a member. Once the sponsoring Elks Lodge reviews the application, it is submitted to the Elks National Foundation Chicago office for evaluation. Contact me for one of the new forms for 2004-05 academic year. Old application forms will not be accepted by ENF office.

2005 Nursing Scholarships

Application forms for the 2005 Nursing Scholarships will be mailed to each Lodge for distribution to your high schools at the same time as the MVS applications. Extra copies will be available at the Fall Convention in October.








1. Used caps with writing on them.

Tribute To A Generation – Elks Salute WWII Veterans

The Dedication of the National World War II Memorial • Washington, DC - May 29, 2004

The Second World War was the largest and most devastating war in history. Freedom was threatened as never before. In a show of resolve and unity this country had never before experienced, Americans from all walks of life joined together to defeat tyranny. Sixteen million served in uniform. Millions worked at home building the world's "arsenal of democracy." More than 400,000 Americans gave their lives. The National World War II Memorial creates a special place to commemorate the sacrifice and celebrate the victory of World War II, the only 20th century event commemorated on the Mall's central axis.

Built into the granite and bronze of the memorial are symbols of special significance. Two flagpoles framing the ceremonial entrance are adorned with the service seals of the Army, Navy, Marine Corps, Army Air Forces,

Coast Guard and Merchant Marine. Along the ceremonial ramps that lead into the plaza are 24 base relief panels that depict Americans at war, at home as well as overseas. Inscriptions reflect a generation's spirit, commitment, and willingness to sacrifice for a cause greater than them.

The historic waterworks of the Rainbow Pool have been restored and contribute to the celebratory nature of the memorial. Semi-circular fountains at the base of the two pavilions and waterfalls flanking the Freedom Wall complement the

waterworks in the Rainbow Pool.

The Lodges and Members of the Benevolent and Protective Order of Elks of the USA were committed to building this memorial and help do so by increasing national awareness of the memorial and with individual contributions of more than \$1.3 million dollars to the ABMC who received more than \$195 million dollars primarily by private donations. Elks Lodges nationwide are continuing their efforts to gather and enter the names of WWII Veterans in the "Registry of

Remembrances" which is housed directly behind the Pacific Pavilion. This can also be done by visiting the Elks web site www.elks.org and view/enter a name in the electronic registry at the WWII Memorial web site www.wwiimemorial.com. The BPOE is also an official partner in the Veterans History Project, getting veterans to record their audio/video stories.

The memorial now stands as a powerful symbol of the national will to sacrifice for the democratic ideals that shaped our foundation and direct our future. For the American Battle Monuments Commission it ends an 11-year effort; and for America's World War II Generation it ends a 59 year wait.

Grand Lodge Resolutions Passed

Change In Voting Procedures Works Smoothly

(This article is reprinted by permission from the *Grand Lodge Convention News, Volume 14, Number 4, Minneapolis, Minnesota, Wednesday, July 7, 2004.*)

Did you notice a change in your voting procedure yesterday? These changes were a result of the vote of the members at the 139th legislative session in St. Louis in 2003. First off, you had to surrender your voting credential as you entered the session and in exchange you received your paper ballot and a pencil. During the Judiciary Committee report, you then marked your ballot with your vote. After the ballots were gathered and read through a scanner, the votes were tallied and the results announced immediately.

PGER Kenneth Moore told the Public Relations Committee that there were three scanners being used, each of which read 2,200 ballots per hour. He estimated that it would take 40-45 minutes to complete the tally after the ballots had been collected. PGER Moore also stated that in the event of an amendment to a resolution the amendment would be voted upon by a show of hands and then the resolution would be voted on via the paper ballot. All in all

it seems like a good change and takes the "guess work" out of the voting process. The actual process took 1 hour and 15 minutes, but the results are unquestionable.

During the legislative session on Wednesday morning the assembled members voted on the proposed resolutions. The following are the results of that election.

- Resolution 2004-1: Passed 2713 to 77; Insure DDGER receives the names of Lodge Officers before the April DD Clinic.
- Resolution 2004-2: Passed 2423 to 358; Require Lodges to be members of State or Territory Association, if formed.
- Resolution 2004-3: Failed 847 to 1938; Allow candidate's immediate family at initiation ritual during special meeting.
- Resolution 2004-4: Passed 2665 to 114; Change "proposition fee" to "initiation fee" to conform to Section 14.290.
- Resolution 2004-5: Passed 1573 to 1210; Allow a non-suspended, unaffiliated spouse to visit the Lodge with a member.

- Resolution 2004-6: Passed 2630 to 155; Allow transferred PER's to be members of PER Association.
- Resolution 2004-7: Passed 2567 to 216; Establishes a quorum for a PER Association or Advisory Committee.
- Resolution 2004-8: Passed 2203 to 508; Removes the prohibition against insurance or mutual benefit features.
- Resolution 2004-9: Passed 2238 to 542; Allow State Associations to participate in voluntary insurance program.
- Resolution 2004-10: Passed 1966 to 825; Require Board of Trustees to report monthly.
- Resolution 2004-11: Passed 2306 to 486; Allows suspension of a former Lodge officer for actions while in office.
- Resolution 2004-12: Failed 1136 to 1649; Allow incorporated Lodges to be governed by Board of Trustees.
- Resolution 2004-13: Failed 758 to 2027; Allow suspension of an accused Lodge officer prior to mediation.

Morehead City – Beaufort Gets New Lodge

MOREHEAD CITY – Frank Oglesby, a 46-year member of the Benevolent and Protective Order of Elks Lodge No. 1710, gazed Thursday through his car window at the empty shell of the building crews began demolishing earlier this week. The fraternal organization recently vacated the Arendell Street structure to make room for a new Eckerd Drug, one of the anchor stores for the renovated Morehead Plaza.

Although Mr. Oglesby and other longtime members may hate to see it, the demolition opens a new door for the Elks, who plan to build a \$1 million dollar facility on four acres off Pond Drive, near the Crystal Coast Business Park in Western Morehead City.

“It’s kind of strange, but it’s a good thing,” Mr. Oglesby said.

He said the 8,600-square foot structure, dedicated when the organization boasted about 150 members in 1961, was now too small and needed too much work.

“A new lodge will draw new members,” he said.

Lodge trustee Sammy Hughes agreed. He said the 300-member organization could possibly double in size once the new 14,600-square foot facility is ready, possibly in December.

“We’re clearing our waiting list and inviting anyone interested in joining,” Mr. Hughes said.

Until then, the group will occupy the storefront between Roses and the new Rent-A-Center store in the plaza’s west wing, where members have set up a makeshift lounge and meeting hall. There hangs the lodge’s 1946 framed charter listing the names of the 45 original members, mostly prominent Morehead City and Beaufort businessmen.

“It was quite the social center for all the businesspeople and professionals in town,” Mr. Hughes said.

The lodge members quickly became active in community service projects. The lodge has sponsored Little League Baseball teams in Morehead City and Beaufort for more than 40 years, and has offered academic awards and scholarships and provided financial assistance to veterans and their families.

“You have to have a purpose for existing other than just having a good time,” Mr. Hughes said.

He said the lodge participates in community service activities locally as well as on statewide and national levels. He said the national organization provides over \$300 million in educational, youth and veteran assistance yearly. In North Carolina, the organization distributed more than \$250,000 in assistance.

“Locally, this lodge contributes about \$9,000 a year directly to veterans’ service and assistance, mainly through the Veterans’ Christmas program,” Mr. Hughes said.

Last year, the lodge also honored local veterans by presenting Blue Star Service Banners to the families of active duty servicemen and women at a dinner in Morehead City.

Nearly 400 people attended the event, which honored members of all branches of service.

The banners gained acceptance during both World Wars and were displayed in the windows of the homes of service members. Each blue star on the banner represents a family member serving his or her country. A smaller gold star is placed over the blue star for each family member who dies in service to symbolize the supreme sacrifice.

Mr. Hughes said the Elks have a long history of support for the military, including the formation of the Veterans Administration hospital system, the donation of lodges for use by the USO, and the scholarship program that became the model for the G.I. Bill.

Mr. Hughes said the organization is planning to offer a new scholarship fund in memory of businessman and member R.E. Willis.

“We just received so many donations in his name. He was the kind of fellow who would give you the shirt off his back,” he said.

Mr. Hughes said the local lodge, unlike many across the country, is holding steady rather than losing members. He said lodge officers expect further growth with the amenities to be offered at the new location, which include a large ballroom, an entertainment facility for members’ children and a swimming pool.

Mr. Hughes said the new location is better because of the recent growth in the western part of the county.


“The demographics of the county are moving more toward the Newport and Highway 24 corridor area. For Beaufort folks, it’s only six minutes further up the road,” he said.



The Southern Pines fire truck was there and children were introduced







Fire Forces Lodge To Close Its Doors

Reading the article heading "Fire forces lodge to close its doors" boldly emblazoned across four columns of the Hometown front page of The Gaston Gazette was enough to bring tears to the eyes of the lodge members.

The shock began for me when Jim Saunders called me at work Thursday morning, July 15, to tell me that someone had broken into the Elks Lodge around 3 a.m., robbed and vandalized it, and then set it on fire.

My wife Barbara and I were very upset with what we were confronted with when we went to the Lodge Thursday evening to see the extent of the damage. David Barber had the front door propped open to let air circulate through the building. Thursday is Bingo night at Gastonia Lodge, or it was. Bingo Chairman Frank Tamberelli and members David Barber, Stephen Falls, and Larry Hostetter were busy telling arriving Bingo players the bad news.

The Bingo players were all disturbed and promised they would be back when the Lodge re-opens and Bingo can resume.

Only one wall in the club room and a part of the ceiling above it was damaged by the fire. Some of the vinyl siding above the rear outside door of the Club Room was warped from the heat. Firefighters had torn out the wall and ceiling to make sure the fire was out. The real damage was caused by the heat from the fire started with our liquor in a cushioned chair. A TV thrown on the fire was totally consumed except for the picture tube. The fire created a lot of heat that melted plastic floral decorations on tables in the Club Room and in the Auxiliary storage room. Over the pool table the Coors light drooped from the heat. The burning plastic of the TV generated a black sooty smoke that filled the entire lodge.

As of Friday morning, July 16, the TV stations and The Gaston Gazette had realized the story potential of the incident. WBTV Channel 3 came to the Lodge early Friday morning and ran a short spot on the 12 o'clock news. Holly, the reporter from Channel 9, interviewed both David Barber and me. I made sure Holly referred to us as an "Elks Lodge" and not a 'club.' The Channel 9



report on the evening news opened with a shot of our poor defiled Elk head. Channel 9 did a really good job with their report.

The Gazette did an excellent article in the Saturday morning paper. This is not how you want to get free publicity. Earlier this year, the Gazette did a very nice article which was well received on the Gastonia Lodge running a good honest Bingo game.

Entry to the lodge was through a broken glass window in one of the outside doors at the back of the Club Room. An individual accompanied by three juveniles ransacked the Club Room, office, and storage areas, taking the cash register with money, alcoholic beverages, snacks, and bingo markers. They hauled off what they could. Later the individual returned and started a fire in a cushioned chair in the Club Room, feeding the fire with various articles and presumably alcohol.

Exalted Ruler Lewis Stevenson called a special meeting to discuss the event. We convened at Jim Saunders home on Friday, July 16 about 6 pm. Twelve Elk members were present as well as seven auxiliary members. The Elk members discussed plans to continue business after the robbery and fire as best we can. The Auxiliary had their own meeting to review the losses in their storage room that housed decorations they have accumulated over the years.

Lodge newspaper editor Jim Saunders issued an early newsletter to notify the members of the robbery and fire. I had obtained a free meeting place at the Gastonia City Club for the July 19, August 16, and September 20 meetings.

After the City inspected the repair, a new meter was installed and the electricity was turned on. Frank Tamberelli had said that he and Larry Hostetter would secure the Lodge by covering the broken window with a piece of plywood. Later Leon Pasour and George Larkin installed new glass in the door.

The insurance adjuster was on the scene Monday after the fire, and began working with Leon Pasour to determine the extent of the damages. The cleanup process is very slow and we have no estimate of a completion date.

Gastonia Lodge had their 'First Friday' dinner August 6 around the pool. About 25-30 Elks, their wives and children enjoyed hamburgers and hot dogs, etc. Many of the members attending saw the fire damage and vandalism for the first time. The fellowship around the pool was great. Everyone had upbeat attitudes with a will to continue and not let this catastrophe destroy our spirits.

We anxiously await the reopening of our Lodge.

Anthony is the son of Lori Green,



Hurricanes Frances And Ivan Leave Marks On WNC

As hurricanes Frances and Ivan worked their way up the eastern coast of the United States, Western North Carolina, located in the Great Smokey Mountains, received massive damage. Haywood County, 35 miles west of Asheville, found two towns, Clyde and Canton under water, roads closed by mud slides and flooding, resulting in hundreds of families who lost all or most of their belongings.

Sharon Jaynes, ER of Waynesville Lodge 1769, called the Lodge into action. With a basement full of clothing and other items scheduled for a fall yard sale, the Lodge decided to donate all appropriate items to the county flood relief program. Monies raised at fund drives such as Thunder in the Valley (a Bikers Rally) and many private donations were utilized to purchase food and other items for flood victims. One Elk, Marti Haney delivered cookies to the Clyde Fire Department. Tammy Poteet, using the

internet, was able to fill a truck with donated items that she donated to the relief effort through the Elks.

With both cash and non-cash donations, it is estimated that the Waynesville Elks donated over \$4,000 worth of food and merchandise. All items were delivered to the county relief centers. That the Elks do Care and do Share was demonstrated by the Waynesville Elks Lodge.


