# Sale of the NC Elks Camp nets \$1,453,546.88 for our Trust

After a little more than one year since the camp was placed on the market, the property has been sold. Two businessmen from the Henderson County area are the new owners. They plan on using part of the camp as a summer camp and developing part of the property.

There were several offers made for the camp, but the State Trustees and officers chose not to accept any offers less than \$1.5 million. We received an offer on January 21, 2005 of \$1,550,000. After some negotiations with the new owners, the offer was accepted and the camp was sold "AS IS". Several items needing repair were found during the final

inspection of the camp, but the board stuck with the "AS IS" clause we added to the contract, and the buyers did agree to take care of those repairs. All of the plaques, pictures, conference table/chairs and other memorabilia were retained and have been placed in storage.

The closing of the camp was held on March 11, 2005. The officers and Trustees of the NC State Association are pleased to announce with all expenses paid, a balance of \$1,453,546.88, which has been turned over to the Charitable Trust for investment in the Gerald and Lea Coates Endowment Fund.

# **MEMBERSHIP: DID YOU ASK?**

Can you believe the Elk year is over for 2004-2005? Do your membership numbers meet or exceed your year ending goals? Do your numbers fall short of your goals? Hopefully you can answer these questions with the following responses: NO, YES, NO.

If for some reason your lodge did not set goals for the past year, we encourage each of the lodges to do so for the 2005-2006 Elk year. Set a realistic but challenging number; give your membership something to strive towards. Challenge the membership in your monthly newsletter and at regular lodge meetings.

Exalted Rulers, it is our hope that each of you have in place a working membership and lapsation committee. Please don't do as so many have in the past, listing a name for various committee chairs just to be able to report to the District Deputy. If your current membership and lapsation chairperson(s) does not have a committee, instruct them to appoint other members to assist them. Should for any reason your committee chairperson(s) is not fulfilling his or her duties, replace them! It is in your best interest, and very much to your benefit, if you have functioning committees.

How do we gain new members in our lodge? Other than attracting members through our various lodge activities and/or community activities, one method for obtaining new members is simply--ask. This is the way in which most of us came to be Elks. Every single member in this state knows someone who is not currently an Elk. Always keep in mind we are looking for quality members.

Retention of current members is very important. This is an area where your lapsation committee must work diligently. Your lapsation committee should meet monthly, at a minimum, to stay on top of your current membership statistics. Making personal contacts with delinquent members is the best means of communication. We must keep the members we have on roll in order to achieve gains. For every member we lose, it takes two new members in order to show a positive.

Exalted Rulers, Membership Committees and Lapsation Committees please familiarize yourselves with the "Membership Program & Planning Manual". (Code 510400, should you need one from Grand Lodge) This manual is a very useful tool in operating successful membership and lapsation committees. Please read the reinstatement information pertaining to the \$1.00 reinstatement fee allowed by Grand Lodge.

Please remember to recognize those members who are eligible for the Grand Lodge incentives. Also any lodge incentives should your lodge have an incentive program. Please also remember to send us the names of all new members who successfully completed his or her job in the "New Members Bringing in New Members" program. We owe this to them as new members and as an encouragement to continue recruiting.

We are confident the members of this great state are capable of turning our current year end loss trends into gains. This actually is a must, not only for the state association but for the national organization as well. We cannot continue to lose members as we have in the past. It is up to us to make a difference, so let's start working on this today!

We wish all of you and your lodge great success during the 2005-2006 Elk year. It is our hope to finish the year with a net gain of at least one in every lodge. Together we can do this. Let's all do our part and all the other things will fall into place. Rachel were all staying in one motel room. Matthew's father was the bread winner and now he was out of work as a self employed concrete worker. Rachel was a full time college student back in Texas and worked a full time



a strange city, no money and thinking you are going to lose a son.

PGER Coates called State President Lee Littiken and asked him to check into this situation and see what the family needed and let him know. State President Littiken called me, Jack Strickland, late in the afternoon on New Year's Eve and asked if I would go to Greenville and check on the family and see what they needed. My wife, Bet, and I immediately went to the hospital and waited in the ICU waiting room to meet a family that did not know we were waiting for them. Every time a family would come to the waiting room, we would ask if they were the Hutson family. Finally a man, woman and two young girls came into the room. I asked if they were the Hutson family. They said "yes". I told them we were representing the Elks of North Carolina and we were here to help them. You can not imagine the look on their face and then came the

We made our way to a private place to have a conversation. Bet and I learned the following from this discussion. Matthew and Rachel were engaged and were to get married in June 2005. During the Christmas Holidays, they went to New Hampshire to introduce Rachel to Matthew's grandparents. On the way back, after getting into NC, the truck they were driving skidded on "black ice" and rolled over several times. Matthew has had several surgeries and will be having even more as he becomes stable. His pelvic area is crushed and will require major reconstruction surgery. Matthew's family flew to NC with little money. Matthew's mother, Juli, his father, Terry, his 16 year old sister, Janelle, and his fiancée

They were renting a car, but were going to turn it back in because they did not have money to keep it.

When Bet and I heard Matthew's father say "I know I need to be back in Texas working to provide for my family, but I can't leave until my son speaks to me or dies", we knew we would stick with them and do anything President Lee Littiken and PGER Coates asks us to do. My wife immediately gave Rachel all the money she had with her and I went to the motel and paid for a week's rent from our lodge charity account.

I notified President Littiken of my findings and he and PGER Coates put things in motion with the NCSEA Trustees to get financial aid to this family. The NCSEA sent \$2,500 immediately to the Kinston Lodge to put in a charity fund to assist the Hutson family. President Littiken got the word out to individuals and lodges and Mike Jones put it on the NC Elks web page. Donations from lodges, individuals, NCSEA and the Texas State Elks have amounted to \$6,340. So far these funds have been used to pay for the motel bill, food, a plane ticket for Terry to go back to Texas, and personal needs. They have now moved into a two bedroom furnished apartment near the hospital and we are paying the weekly rent. Hastings Ford in Greenville provided a car at no charge for the family to use while in Greenville (yes there are angels among us). Bet and I make several trips a week and many phone calls checking on Matthew and his family. Naval Chaplain Lt. Commander Bryan Finch and I work together to see that both the military and the Elks are meeting the family needs in a satisfactory

# **News From Camp Carefree**

Thanks to the support of the Elks, Camp Carefree had another successful year. During the 2004 summer season, six (6) one week sessions were held and 338 children received a free camping experience. A breakdown of campers by session follows:

O. Carlson of Broad Creek and Wendi O. Johnson of Wilson; a sister, Katherine M. Oglesby of Olympia, Wash.; and four grandchildren. Frank went through the chairs in Kinston Lodge #740 after

becoming a member in 1959, and he served that lodge as Exalted Ruler in 1963-64. He was District Deputy Grand Exalted Ruler while a member of Fayetteville Lodge #1081, and later became President of the NC State Elks Association in 1983-84 while a member of New Bern Lodge #764. Frank received the "Thad Eure Distinguished Service Award" from the State Association in 1990, and to his great delight was named in 2003 as the "Online Elk of the Year" for his participation in a national internet bulletin board of the Elks website. Frank was very

knowledgeable about the Elks bylaws and Grand Lodge Statutes and served in a wonderful capacity on the NC State Elks Bylaws Committee. Frank was everybody's friend, and he was known as a "brutally Frank" straight shooter who would give you the answer, rather than what you wanted to hear. He also had a quick wit and a magnificent sense of humor. He was a fixture at district, state, and national meetings and conventions, and had attended thirty-seven Grand Lodge Sessions over the years. The "Law Man" will be missed. Indeed, he leaves behind a vacant chair which can never be filled again.





Asheville Lodge # 608 held its Annual Children's Christmas Shoe Party on December 19th. This has been the Lodges favorite Charity for the past 70+ years.


