

bikers slowly maneuvered the narrow roadway in route to the parking lot beside the indoor riding arena. Was this a group bust? No way! It was part of the 1st Annual Camp Carefree Ride & Raffle sponsored by the North Carolina State Elks Association and Plum Krazy's Sports Bar & Grille.

After arriving at Camp Carefree, the riders and other interested parties who made the trip in four wheeled vehicles. gathered in the riding arena and were greeted by Anne Jones, Camp Carefree founder and Executive Director, along with Michelle Richardson, Camp Director, and several volunteer counselors. Anne spoke about the history and mission of the Camp and the wonderful things they do for the children. She thanked the riders and others for their participation and support. Have you ever been in a room full of big, burley, black leather clad bikers and their ladies and seen them all crying or so choked up they couldn't speak? Well, you should have been there.

A tour of the Camp followed, and then the bikers were back on the road to continue the ride.



The Ride & Raffle was a day long event. Assembling at Plum Krazy's at 11 AM, the riders left Plum Krazy's and arrived at the Greensboro Elks Lodge around noon, where they enjoyed true Elk's hospitality and were treated to a BBO lunch provided by the Lodge. At 2 PM, Guilford County Sheriff's deputies escorted the caravan of riders up US 220 to the Rockingham County line where they were met by Rockingham Deputy Sheriff's and escorted to Camp Carefree. From Camp Carefree, the Deputies escorted the riders down NC 68 back to Guilford County where the Guildford Deputies were waiting to escort them back to Greensboro and to Plum Krazy's for fun, fellowship and a celebration party and raffle. Two bands performed, free food was provided and dozens of items were raffled off including two minichoppers. Frank Tamberelli won one of the mini-bikes and donated it back to be sold with the proceeds going to Camp Carefree.

I lost a great friend on May 24, 2005 as I answered the phone in the early hours of that morning to learn that John Dennis Sullivan's travels through this life had come to an end. He had passed through the valley to rest with our Maker. His leaving has caused a void in the lives of his family, friends and our state association.

John had a deep impact on our Order as he has served the Southern Pines Lodge since his initiation in 1959. I testify to this as he served as their lodge secretary from 1975 until 2002. He served in all the chairs, including being Exalted Ruler in 1963-64. John served this Association with the same vigor. He was State President 1971-72. During his term the membership of North Carolina Elks reached its highest in our history. He was appointed State Secretary by then President Bill Allen in January



1982. I'm sure Bill never thought he would appoint an Elk whose service would span twenty years. John was appointed to the Grand Lodge, Lodge Activities Committee in 1977. Our Association bestowed the "Thad Eure Distinguished Service Award" on John in May 1975.

My first memory is of John Sullivan seated at the Association's meeting next to the Honorable Thad Eure; the "Oldest Rat" in the party as he use to say. I was impressed at John's ease in carrying out his duties as State Secretary. His nature was to "help his fellow man". John lived this each day. He must have received the greatest indoctrination when he became an Elk



or what could inspire a man to have such qualities? Over the years I've decided that these principles of ours, Charity, Justice, Brotherly Love and Fidelity were the path which John lived his life. He practiced this philosophy each and every day. He encouraged other members to contribute to this Association.

There is little in our Order of Elks, which John was not a part of during his tour of duty. John did share with me that the greatest honor he was accorded was by his friend, Jerry Coates, as John was asked to give the seconding to the nomination of Gerald Coates for Grand Exalted Ruler in Las Vegas in July 1996.

I cannot impress upon you how much John Sullivan was such an important part of my involvement in our Order. During my last visit with John, I asked what I could do for him. John replied, "I've had a good life, tell my friends that."

Ever since that day I've prayed that the Lord will give me the wisdom and integrity that John possessed.



Linda and I thank them for all their hard work. We had Elks from many states pay us a visit and enjoy the hospitality and Brotherly Love North Carolina is known for. If you have never attended a Grand Lodge Convention you owe it to yourself to take the time to attend and learn more about the great Order of which we are members.

Last year North Carolina had an increase in membership, however this is not true throughout our Order. Our State Sponsor PGER Gerald Coates has issued a challenge to the State Association to add lodges in North Carolina. Last year South Carolina added two lodges in an area already served by large well established lodges. We in North Carolina can do the same. There is not a lodge in our state that is not close to a town or city that could support a new lodge. For the benefit of all Elks I ask each Lodge to take a close look at surrounding communities and find a willing member within their Lodge to work with the State New Lodge Development Committee in exploring the possibilities of establishing an Elks Lodge in that town or city. If you need more information please contact your District New Lodge Development Committeeperson.

This year our Charitable Trust has, for the first time, set a goal of \$2.50 per capita for its fund raising goal. Our Endowment Fund is set up similar to the Elks National Foundation where the principle is invested and can never be touched; the interest will be used for the charitable works of our State Association. Donations today will pay great dividends in future years as this fund grows and we receive more in earnings from this fund. I urge all members of our State Association to make an annual pledge to the Gerald & Lea Coates Endowment Fund to assist with our charitable goals. Remember all donations are tax deductible.

Benovelence Is Our First Name

North Carolina's Elks have a history of charitable giving. When hurricane Floyd flooded the eastern part of our state the Elks stepped up to provide relief. When flooding hit the Dakotas the Elks of North Carolina were there with donations to help those in distress.

We have always been in the top ten percent of giving to the Elks National Foundation. We were able to maintain this level of giving while also providing relief to those in need.

Just recently a service man was critically injured in a traffic accident. His family needed help to allow them to remain at his bed side while he recovered. The Elks of North Carolina provided the necessary funding to allow his loved ones to remain close.

In 1997 we established the Gerald and Lea Coates Endowment Fund for

the charities of the North Carolina's Elks Association. The intent of this endowment fund is to provide financial support to various charities in our state. This fund was set up with the intention that only the earnings of the fund would be used for out charities. Our goal was to build the fund until it reached a level of one million dollars before using the earnings. In 2004 our state association sold its camp which infused one point four million dollars to our trust. We are now in a position to use earnings from this fund to support our charitable works.

We still need to continue to contribute to our own trust to provide for the increased needs of our state charities. We can maintain our level of giving to the Elks National Foundation and still give to our own state trust.



John Boyd, Editor, of North Carolina Elks News, received the four star award for the fourth year in a row. GER Grillo presented Boyd with the award at the Fall State Convention in Hickory.

At our state meeting we have had contributions from lodges in the state present their gifts to the trust. In addition to these contributions the Ladies of our state have also been very generous with their contributions to our charities. We also rely on individual contributions from our membership and their family members. We ask that every Elk in the state fill out a pledge form and donate on an annual basis to our charitable works. We have set a goal of \$2.50 per capita for each Lodge this year. Which Lodge will be the first to reach this goal? The trust will be awarding plaques to Lodges that report the highest level of per capita contributions to our trust.

Each individual who gives a contribution of at least \$10 will receive a lapel pin to signify their support of our charities. There are special pins for contributions of \$100, \$500, \$1,000 and a very special Diamond Award for donations of \$10,000 or more. We also encourage members to make bequests in their will to the trust. This can be done now with gifts being given in the future. What better way can we remember a deceased member by making contributions to the trust in their honor. This can provide a living memorial to our deceased members.

All of these donations are tax deductible the trust is covered by 501 (C) 3 of the tax code. HAVE YOU FILLED OUT YOUR PLEDGE YET?

It is planned to hold our next Officers Training Seminar in February 2006 at Camp Carefree, please put this date on your calendar now, do not miss this great opportunity.



High Point and Calabash Work Together to Co-Host NC School Resource Officers

Nearly 400 law enforcement officers, representing 70 of North Carolina's 100 counties, recently participated in the annual NC Association of School Resource Officers 5-day state conference. The official host for this year's conclave was High Point Lodge 1155. Most of the Elks Lodges in NC alternate sponsorship of this event on an annual basis. However, as the 2005 meeting was scheduled at Sea Trail Plantation, the Calabash Lodge agreed to co-host a barbecue dinner that was attended by 250 law enforcement officers, family members and 27 Elks from the High Point Lodge.

The Association provides uniformed officers to high schools and middle schools to assist the school's administration in maintaining a safe and secure educational environment. In addition, they promote

Money raised from our annual golf tournament pays for Fun Day, poster contest, dances, Halloween party and computers for schools that have classes for children with disabilities.



Raleigh Lodge #735 support military and their families through USO donations

The Brunson family of Fayetteville didn't spend the Fourth of July watching a parade, grilling steaks or oohing and ahhing at the rocket-red glare of fireworks. Instead, family members spent the last two hours of a two-week reunion in the USO lounge at Raleigh-Durham International Airport. They waited for a delayed flight to take Army Capt. James Brunson, 28, back to Iraq to finish a yearlong tour of duty.

His wife, Soojin, 32, thinks the Army has a lousy sense of timing.

"When he left the last time, he left on the worst day possible -- his birthday," she said, underscoring his initial Dec. 30 departure for Iraq. "This time, he leaves on a special day -- the Fourth. We can't go to fireworks because Daddy's not here."

The airport's 11-month-old USO lounge was a quiet refuge for the Brunson family, which includes son J.C., 2, and daughter Ashley Renee, 7 months.

But for most of the holiday weekend, the lounge was a crowded hot spot filled with military men and women and their family members -- an extension of the unexpectedly heavy demand for service that has USO officials calling for more cash donations. "We're finding out we're filling the need," said Carol Palmer, assistant director of the USO of North Carolina's RDU Center. "We just need to be able to pay to fill the need. Our donations are way down, and we need the community to step forward and start giving so we can keep this center open."

When the club opened in August, the staff expected to serve about 1,000 military people a month. Instead, the club is averaging twice as many visitors, a boom that led staff to start round-theclock hours in January.

Palmer worries about the increased demands on the club's 155 regular volunteers. But she's more worried about a busted budget.

"We flat-out need the money," said Palmer, who notes that the club will have a fund-raiser at the Woman's Club of Raleigh on August 13.

By 4 p.m. Monday, the head count of holiday visitors topped 450, said Palmer, who expects to host another rolling wave of travel-weary soldiers, sailors and Marines today.

One night early in the weekend, every plush lounge chair was filled with snoozing military folks. Palmer and her sister did eight loads of laundry -sheets, blankets and pillowcases. "Any holiday weekend, we get slammed," she said. "I feel like I have 200 sons."

Laundry loads and a steady stream of military people ducking in to grab a quick bite, relax with a video game or check their e-mail are signs of success for the USO's airport club, which is housed on the second floor of the airport's Terminal A extension. The club occupies office space the airport authority spent \$100,000 to renovate.

Palmer knows about the death and carnage in Iraq. But she sees firsthand the quieter sacrifice of military folk and the families they leave behind.

"They miss so much being gone," she said.

Brunson and his wife will observe their fourth wedding anniversary Thursday. He'll be in Iraq, serving as a quartermaster for a command-andcontrol unit based at Camp Anaconda, about 30 miles north of Baghdad.

His daughter has just started to crawl. By the time he comes back in late December, she'll be walking.

Although he isn't in a combat unit, he has had a brush with death. A mortar round blew a hole in the concrete wall

of the room where he worked. No one was hurt.

All this makes family time a precious commodity that aces out a national holiday.

"I've always enjoyed July Fourth, going to fireworks in the evening," Brunson said. "I'll miss that. But compared to the two weeks I got to spend with family, it isn't that big a deal."



We are extremely grateful for all the financial and moral support we have received from other Lodges and individuals."

We will be forwarding a donation to the Elks to further help with this effort.


