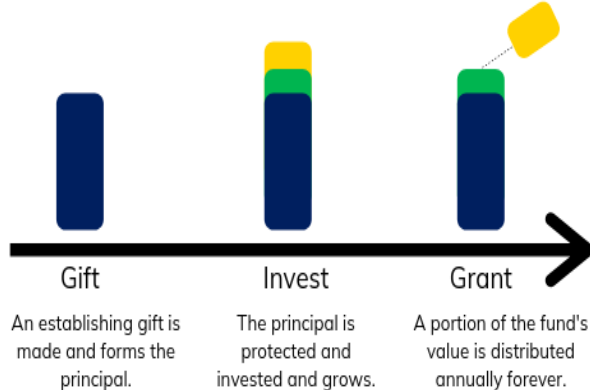
WHAT IS THE CHARITABLE TRUST?
